## Terms and Conditions of Crowdpear Invite a Friend Program

Updated on November 10, 2025

- 1. These Terms and Conditions of the Crowdpear Invite a Friend program are valid from November 10, 2025 until Crowdpear makes a separate public announcement regarding the termination of this program.
- 2. Any Crowdpear verified Investor (further User) has the right to participate in the Invite a Friend Program during the time frame indicated in Clause 1 if the Crowdpear generated unique Promo Code or link is available on the User's Account on Crowdpear.
- 3. The User and the referred party each receive EUR 20 (twenty) Reward if the referred party invests at least EUR 300 (three hundred) within 30 (thirty) days after registration on Crowdpear. Please note that the referral bonus is applicable only for investments on the Primary market. The bonus is not applicable if the investment is sold on the Secondary market. The bonus is paid in EUR in one installment after 7 (seven) days after all conditions set in these Terms and Conditions are fulfilled. The referral bonus is considered paid when it is credited to the user's Crowdpear account. The bonus is paid according to the conditions valid on the day of the bonus payment.
